



Change of legal form of Schwartauer Werke - The most important answers to your questions

When will the change of legal form be complete, i.e. from when will the new designation of the legal form come into effect and be used?

When Schwartauer Werke GmbH & Co. KG is entered in the relevant commercial register, which has been earmarked for 1 August 2022.

Will the billing addresses remain unchanged?

Yes, the address itself will remain as it is, but the recipient must be changed from Schwartauer Werke GmbH & Co. KGaA to Schwartauer Werke GmbH & Co. KG.

Will the bank details remain unchanged?

Yes. The bank details have not and will not be affected by the change of legal form.

Will the delivery addresses remain unchanged?

Yes, the address itself will remain as it is, but the recipient must be changed from Schwartauer Werke GmbH & Co. KGaA to Schwartauer Werke GmbH & Co. KG.

Will the VAT ID number change?

Yes, the new VAT ID number is: DE 353 639 472.



Will the tax number change?

Yes, the new tax number is: 25 288 49700.

What happens with orders/invoices that were issued prior to the change of legal form (probably on 1 August 2022)?

Invoices that are issued prior to this date (probably until 31 July 2022) will be processed as usual. From the time that the change of legal form comes into effect (probably from 1 August 2022), all invoices must state the new company name as Schwartauer Werke GmbH & Co.KG.

Are the guarantees still valid as issued?

Yes, the change of legal form preserves the identity of the company. Only the legal form will change, which also changes the designation of the legal form.

Will there be an official letter addressing the change of legal form?
